# RISE license price list for research and advisory

### Scope of services

BFH grants the licensee an exclusive, fee-based licence to use RISE for their own personal use and for advising third parties. With the purchase of the licence, software access to the RISE method, working materials and support are provided. Depending on the choice of the annual licence, a certain number of user accounts is acquired with which an unlimited number of farm surveys (= questionnaires) can be created.

### Additional Services

One hour of support is included in the price of the annual licence. Additional support such as entering new regions into the database, maintaining master data, setting up software, etc. is charged at CHF 125 / EUR 125 / USD 135 per hour.

### Billing

BFH shall issue an invoice to the licensee with or after confirmation of the licence agreement, payable within thirty (30) days.

Bank charges for payments in foreign currencies shall be charged to the licensee.

Services such as additional support or user accounts will be invoiced at the end of the contract period.
